I say and declare:

1. My name is Andrew Thomas Sinclair. I am one of the attorneys for Petitioners in this action.

2. Petitioners have designated as trial exhibits a number of booklets and related materials that contains statements by the Regents regarding the availability of University-sponsored group health coverage during retirement. The following is a list of the relevant language in these benefit booklets. Consult the exhibit for the complete wording of the document.

3. In the mid-1980s, the Regents began to include "reservation of rights" language in the benefit booklets. This language if not relevant to the two issues that are addressed in this phase of the trial and are not included in the summary set forth below.

4. With regard to conventions followed, we made our best effort to identify the date of each document. This was not possible to do in all cases. Often the date would appear in small type on the back page of the document. We adopted the following approach. When only a year was listed, we used, e.g., 1/1 followed by the year; when only a month was mentioned, we used, e.g., 5/1, followed by the year. When a particular date could be identified, we used that date. With regard to the entries below, we used the name of the document on the top line in bold. We then indented the relevant language. When a section name was relevant, we underlined the name regardless of the formatting in the document itself.
